We have two sessions broken down in two blocks. The sessions are for the whole fall or spring session, once you are signed up the tuition will be owed for that entire session.

There is a one-time \$35.00 registration fee for new students. Tuition is due on the 1<sup>st</sup> of the month. You must put a credit card on file for tuition to be ran on the 1<sup>st</sup> of every month. The following is the price list for classes. There is a discount for siblings.

\$50.00 per month for 1 30 minute class per week.

\$80.00 per month for 1-hour class per week

\$80.00 per month for competition class per week

\$30.00 per month per sibling for 1 30 minute class. If I have a sibling example \$80.00 a month for (2)

Monthly tuition will remain the same, regardless of how many classes are in a month. If the gym is closed at any time due to covid, or any other reasons tuition will still be owed.

We will take pictures and videos during classes to use on social media. Please let us know if your child is not to be used in any way for this and we will do our best to make sure they are not.
